# WILL SAYS (PLAINTIFF/LIABILITY)

## 1. Dr. Roy O'Shaughnessy

Dr. Roy O'Shaughnessy is a forensic psychiatrist. He will be subpoenaed to speak to his appointment by Providence Health Care and the Vancouver Coastal Health Authority as a member of the review team performing an external independent review published in August, 2012 (PL 1.102), and the contents thereof.

# 2. Mercy Osuteye

Mrs. Mercy Osuteye is the declaratory third party Nicholas Osuteye's mother. She will speak to Mr. Osuteye's background, including her observations of his symptoms at the time of onset of his schizophrenia, through until his admission to Misericordia Hospital in June and July, 2012. She will describe the violent episode that led to that hospital admission. She will also speak to her observation of his medication compliance history. She will speak to her involvement in a meeting with her son's care team at Misericordia prior to his discharge in July 2012. She will also speak to her observations of Mr. Osuteye's health and wellness now, under a compulsory treatment and monitoring regime.

# 3. Michael Osuteye

Michael Osuteye is Nicholas Osuteye's younger brother. He will speak to his observations of his brother's symptoms over time, and he will describe the violent episode that led to Nicholas's admission to Misericordia Hospital in June, 2012. He will also speak to Nicholas's post-discharge behavior in July 2012.

#### 4. Dr. John Dewart

Dr. Dewart was Nicholas Osuteye's treating psychiatrist at Misericordia Hospital in Edmonton, Alberta between June 9, 2012 and July 11, 2012. He will speak to the content of his records and those of the Misericordia Hospital [HL 1.34 and PL 1.108].

### 5. Rosalie Rossi

Ms. Rossi is a social worker. She will speak to her casenotes, following her meetings with Nicholas Osuteye on November 27 and 29, 2012. She will speak to her concerns about medication compliance, and her communications in this regard with Beacon Shelter staff.

## 6. Patrick Murphy

Mr. Murphy worked at the Beacon Shelter at the material time. He will speak to the notes in the file at PL 1.109 / HL 1.36.

## 7. Kylie Dunn or Mauro Carvajal

Ms. Dunn and Mr. Carvajal were BCEHS attendants 77919 and 78024 and will speak to the patient care report dated December 5, 2012, including their observations of the patient's symptoms and his self-report of having walked since 0700, and hallucinations.

#### 8. Dr. Rachel Jane Wai-Chee Li

Dr. Rachel Li will speak to her notes recorded on the Emergency Physician Assessment following her interview of Nicholas Osuteye in the early morning on December 6, 2012. She will speak to his self-reported auditory hallucinations, and her observations of his symptoms during the interview. She will also speak to his self report of not having taken risperidone in "1-2 days".

#### 9. Allison Jordan

Ms. Jordan is a registered nurse at St. Paul's Hospital. Her evidence is reflected in her sworn affidavit of 4/JAN/2019.

### 10. Arian Khosravi

Mr. Khosravi will speak to his observations of Mr. Osuteye's attack on Ms. Crawford.

# 11. Cst. Bradley Cook (2375), VPD / Delta Police

Cst. Bradley Cook, then with the VPD, will speak to his observations during his arrest of Mr. Osuteye and his audio recording of that arrest.

# 12. Mike Dewar, retired VPD constable (1436)

Retired Cst. Mike Dewar will speak to his observations of Mr. Osuteye during his arrest, and his search of Mr. Osuteye's belongings.
